### Examination of injured party Hana Fejzić

Hana Fejzić lived with his son Safet (b. 3 January 1978), her daughter Safeta and her husband in the village of Mušići in Srebrenica municipality. She last saw her son on the morning of 10 July 1995 when he and his father fled Srebrenica and took to the woods. He wore a blue Addidas tracksuit top, a T-shirt underneath, a pair of grey trousers, and a pair of sneakers a friend had made for him from his mother's overcoat. The husband's body was exhumed from a mass grave at Cerska and the son's remains found at Godinjske bare in 1999. Identification by DNK matching was carried out in 2003. Ms Fejzić identified her son in a photograph shown in the courtroom.

## Examination of injured party Safeta Muhić

Safeta Muhić last saw her brother during the attack on Srebrenica, as he and his father ran into the woods and she and her mother made for the UNPROFOR base at Potočare.

The Trial Chamber President showed Safeta two photographs and she identified her brother Safet in them.

### Examination of injured party Nura Alispahić

Ms Alispahić lived with her son Azmir in Srebrenica until the enclave fell. Azmir was 16 at the time. She last saw him as he made for the woods in the company of male relatives to escape the VRS. He had on a pair of sneakers, white socks, a pair of jeans, a jacket and a T-shirt underneath. He carried a bag with some food and his brother's trousers and shoes inside. She identified Azmir in the two photographs shown her by the Trial Chamber President.

#### Examination of injured party Osman Salkić

The executed Azmir Alispahić was Osman Salkić's brother in law and the executed Sidik Salkić, aged 35, was his close relative. He took the underage Azmir into the woods but lost sight of him after a while. When shown three photographs, the witness identified Azmir in all three and Sidik in two.
